The library hosted the Lord of the Gourd and treated participants to slices of fresh watermelon to compliment the carved watermelons created by Lord of the Gourd. Storytime on Tuesdays at 10:15 a.m. with Miss Mo averaged 25, Lego Discovery with Miss Mo began on June 26 with a group of 24, the What is a Watershed program with Tip of the Mitt Watershed had an audience of 9, the Science of Cotton Candy brought in 75 people with the two programs offered. Monarchs Matter was rescheduled for Tuesday, July 29 at 6 p.m. in the Neuss Room.

Maureen (Mo) Stein has been hosting Storytime on Tuesdays at 10:15 a.m. since May 20. She has also been leading the Lego Discovery groups on Thursdays at 11 a.m. since June 26. We are excited to welcome her to begin working for the library in Children's Services full time on July 21, 2025.
